(JROTC Cadets, 4H Members, Boy Scouts, Girl Scouts, instructors, Scout Masters, 4H Leaders)

Rules: CMP rule book 2006 – 2008 (due out in October) with exception of type of air rifles (No CO2 rifles). Competitors must fire all three positions in the same session. Download rules at: <http://www.odcmp.com/3P/Rules.pdf>

Awards: Trophies for top three individual shooters in each category and top score overall in each position.

Range: Range will comply with CMP rules and regulations. Liberty County High School range is available for use with prior notice.

Entry Fee: \$5 per individual. Organizations may consolidate entries. Make checks payable to: LCHS Rifle Team.

Mailing Instructions: Mail targets to LCHS Rifle Team, PO Box 519, Bristol, FL 32321. Please print or type information neatly on labels or target.

Equipment/Clothing: IAW CMP rule book. Note: Please pay close attention to footwear rules.

Targets: Use AR 5-10 targets (Twelve bulls – 2 sighting and ten scoring. Teams will provide targets (If you need targets contact LTC Minyard). Targets will not be scored or gauged. LCHS will score targets.

Labels: The following will be placed on the upper right corner: Organization Name, Shooter Name, Position, and Date.

Scoring: Targets will be scored by Liberty County and results published via email. Top four scores will count for each team. Cadets with low overall scores will still be eligible for high position award.

Course of Fire: Three position 3x10 course of fire on official 10 meter air rifle postal targets (AR 5-10).

Entry Deadline: Postmarked no later than December 8, 2006

Dates to Fire: Between October 1 to December 8, 2006
