OFFICIAL PROGRAM RULES AND REGULATIONS 2014 ARKANSAS STATE BB GUN CHAMPIONSHIP MATCH

February 7-8, 2014 C.A Vines 4-H Center, Little Rock, AR.

ELIGIBILITY:

Entry in the Tournament is open to any youth who:

- a) Has completed the Daisy Shooting Education Program or an "Equivalent' safety course of instruction.
- **b)** Is sponsored by a recognized youth organization such as 4-H, Boy Scouts, Royal Rangers, Local Civic Organization, Church Youth Group, or similar organization with responsible adult leadership.
- c) Is within the age limits: Boys and Girls ages 8 through 15. Competitors must be 8 years of age at the time of competition and may compete to their 15th year. NOTE: 2012 NRA Rule Book Change- The age of the competitor shall be determined by the date of the first shot going down range for each tournament. Photocopy of each competitor's birth certificate must be available upon request
- **d**) Is a regular or alternate member of a community based shooting program.

REGISTRATION:

Registration fee is \$55.00* per participant/coach, which includes registration fee, lodging on Friday night, and breakfast and lunch on Saturday.

Registration fee is \$35.00* per participant/coach not requiring lodging and breakfast.

Dinner will not be offered on Friday or Saturday night.

Registration Deadline is January 11, 2014. Registration and fees must be postmarked by January 11, 2014.

LATE REGISTRATION: Registration postmarked after January 11, 2014 will be \$65.00* All registration must be received by January 18, 2014.

*REFUNDS AND CANCELLATION POLICY. Refunds on Registrations will be prorated as such, based on Match Date of February 7, 2014.

Cancellations 10 days before Match Date-Full Refund.

Cancellations 5 days before Match Date-50% Refund.

Cancellations within 5 days – No refunds, however emergency situations will be considered by Match Director.

Ranges will be open for practice and sight-in after the written test on Friday night February 7, 2014 from approximately 8pm till 10:30 pm. Teams that wish to sight-in and practice must be accompanied by a coach or leader from their county.

COMPETITION:

Teams will be composed of five regular members, with up to two alternate members. Team members will compete for team and individual awards, and alternates will compete for alternate awards only. Scores of alternates will not count toward team total scores.

This will be a NATIONAL RIFLE ASSOCIATION sanctioned event.

COACHES

Coach must be registered and registration fee paid.

There is a requirement that each team (including the team of five and up to two alternates) must provide at least one coach of record for each team. Alternative coaches are encouraged.

Teams without a designated Coach can not participate. Designated Coach(s) must attend meeting on Friday night for Coaches.

Please note: Coaches are allowed and encouraged to assist their shooters on the firing line. Coaches are allowed to assist shooters with cocking and loading guns, sight adjustment, shot placement, etc. Teams are encouraged to have alternate coaches, however all alternate coaches must be registered, fee paid, and attend the coaches clinic. During the match, alternating or substituting the coaches on the firing line is allowed as long as coach meets above requirements. Only registered coaches are allowed to review targets for scoring purposes.

Each team will be required to have a coach that meets the above requirements.

RANGE SPOTTER

Each team can have a "spotter" placed behind the shooter with a spotting scope or binoculars that will assist the shooter and coach. The spotter can note shot placement and relay information to the coach/shooter. To avoid noise and disruptions on the line, hand signals for sight placements must be used. Teams must provided their own spotting scope or binoculars.

EQUIPMENT

- Required equipment is the Daisy Model 499 BB gun. Modifications to the Model 499 are specified and listed in the NRA BB Gun Rules, 3. EQUIPMENT AND AMMUNITION
- Sights-Daisy Model 5899
- Slings-Refer to Official NRA BB Gun Rules
- Ammunition-Will be provided by Match Director. Only Daisy Precision Ground BBs shall be used. Ammunition will be issued at time of registration. Ammunition can be inspected at any time by Match Director or Range Officials to ensure they are unaltered Daisy Precision Ground BB's.

Stocks-Factory installed stocks must be used. Any alteration to such stocks is governed by NRA Rule 3.4. Coloring of stocks is permitted provided such coloring does not violate Rule 3.18

(Please note that guns, sights, slings and ammunition can be inspected prior to and during event competition. Equipment that does not meet rules/guidelines will not be permitted. Equipment that does not meet rules/regulations found during the match competition can result in participant, team, and organization disqualification from the match)

- Eye protection will be required.

Daisy National BB Gun Championship Match Teams

Only members of the winning 1st, 2nd or 3rd place teams at this state match or their designated team alternates will be allowed to shoot at the DNBBGCM to be held in Rogers, Arkansas in July of 2014. In the event that a 1st, 2nd, or 3rd place team is unable to attend the DNBBGCM the next highest scoring team will be invited to attend. Each 1st, 2nd or 3rd place team traveling to and competing in the IBBGCM will receive a \$1000.00 Visa travel voucher.

NO PICK-UP OR STATE ALL STAR TEAMS ARE ALLOWED AT THE DNBBGCM.

CONSECUTIVE MATCH EXCLUSION:

Individuals who competed as regular members of a team at the DNBBGCM can not compete as a regular team member at the State and/or DNBBGCM the following year. This rule

assures that new shooters will get a chance to compete. It is the responsibility of the team's coach to assure that all participants meet this requirement.

*Team members or individuals that competed last year at the DNBBGC will not be able to compete as a regular team member at the State Match or DNBBGC again this year. (Please refer to the DNBBGC rules for details.) Coaches must be aware of this rule when building teams for the state competition. However to allow these "alumni" shooters a chance to compete a special "alumni only" category will be established for individual only competition. Alumni shooters will compete in all four shooting categories (prone, standing, kneeling, and sitting) but not in exam. The top three overall winners will be recognized for an award.

CONDUCT OF THE TOURNAMENT:

Safety is the number one concern of all match officials, adult leaders and competitors. Proper safety procedures will be enforced at all times. During competition, infractions will be noted and one warning will be issued to the shooter and his/her coach. A second infraction will result in disqualification of the shooter.

Rules: The National Rifle Association 5-Meter BB Gun Rules and the Official Match Program will govern local and State Championship Matches unless modified by a Match Director's Bulletin. Such Bulletin will be published separately from this Match Program and posted on the Official Match Scoreboard. Conduct in the Arkansas State BB Gun Championship Match will be governed by this DBBBGC Rules and Policies, Arkansas State Official Match Program and the current NRA 5-Meter BB Gun Rules.

COURSE OF FIRE:

The BB gun match consists of 40 shots for record fired at 5 meters (16ft. 4 ¾ inches) in four stages with a 10 minute time limit for each stage as follows:

MATCH 1: 10 Shots from the Prone Position, NRA Rule 5.6.

MATCH 2: 10 Shots from the Standing Position, NRA Rule 5.12.

MATCH 3: 10 Shots from the Sitting Position, NRA Rule 5.8.

MATCH 4: 10 Shots from the Kneeling Position, NRA Rule 5.10.

TARGET: The official target for the IBBGCM will be the NRA 5-Meter BB Gun Target AR-4/10.*

* Please note: New This Year, the Arkansas State BB Gun Competition will utilize the Orion Scoring System.

WRITTEN TEST:

In addition to the regular course of fire as outlined above, each competitor at the Arkansas BB Gun Championship Match will be required to take a written test covering topics on gun safety and marksmanship. Source material for the test will be the Daisy 10 Lesson Curriculum

Guide and the NRA 5 Meter BB Gun Rule book. The exam will be worth 100 points and will be equal in points to any one of the firing stages. Exam scores will be calculated in team totals to determine the overall winning team. Written score will also be used in aggregate scores for Alternate and Team Member Individual scores. Written test scores will be posted on the scoreboard after the final shooting scores have been posted. The NRA 5 Meter BB Gun Rule Book is available thru the National Rifle Association. The Daisy 10 Lesson Curriculum Guide is available thru Daisy NBBGC website.

AWARDS

1st, 2nd and 3rd place awards will be presented to the winners in each of the following categories:

ALUMNI DIVISION

Alumni High Aggregate 1st thru 3rd

In addition, all competitors scoring 100 on the written exam will receive a special Certificate of Recognition.

OTHER PRIZES/AWARDS

In addition to trophies and awards listed above, 1st thru 3rd place teams and 1st thru 3rd place individuals, and alumni, and alternates may be eligible for additional awards and prizes provided by sponsors. These may include gift cards, firearms, BB or Air Guns, and related shooting items. Winners must meet any local, state or federal requirements to receive.

SANCTION OF EVENT

This will be a Sanctioned event through the National Rifle Association.
